Beijing-Humboldt-Forum Award

General Regulation

Beijing Humboldt Forum Organization Committee sets up the Beijing-Humboldt-Forum Award (hereafter referred to as BHF Award) to promote the scientific research in the field of "Green Economy" and "Cultural Heritage" as well as the cross-displinary and cross-border communication between young scholars from China and Germany.

An independent Selection Committee composed of academics from all disciplines makes the final decision on the nominations received. The competition between nominations is international and there are no quotas for countries or disciplines. The nominee must be under the age of 35 at the time of the opening ceremony of BHF in 2016. They must participate in the BHF and contribute a report.

BHF will select the award winners among the qualifying young academics (domestic and international) by their reports. The BHF Award is valued at 10000 RMB (after tax). The award winners are invited to spend a period of one month participating in study and research in CEM Halle (Chinese winners) or at UIBE (International winners). Round trip flight and accommodation during the research are afforded by visiting institutions.

Selection Committee

The Selection Committee for BHF-Award is established to ensure a scientific, objective and impartial allocation of BHF-Award.

The Selection Committee is appointed by Beijing Humboldt Forum.

The committee consists of a chairperson, several vice chairpersons and specialist committee members. The chairperson and vice chairperson are nominated by the Selection Committee. After the term-end or the step-down of the committee members, the Selection Committee nominates new candidates and alternate new committee members with the permission of BHF.

Members of the Selection Committee shall

- conduct research in the field of "Green Economy" and "Cultural Heritage";
- have a signifikant impact on their own discipline;
- be possessed of academic ethics and good academic judgement;
- own great sense of social responsibility;
- be objective, just and enthusiastic about public welfare undertaking.

Members of the Selection Committee are responsible for

- Determination of the eligibility criteria;
- Deliberation on the documents of nominees and the determination of the award winners;
- Record the selection procedure.

Selection Procedure

Academics must submit the abstract of report and resume to IC/DC of corresponding session before 8. 30. 2016. The abstract can be written in Chinese/English or Chinese/German and it should be no longer than one page. The deadline for the whole article is 09. 05. 2016. IC/DC decide whether the report is accepted as session report or not.

IC/DC can recommend outstanding nominees to the Selection Committee. The academics can also submit the reports directly to BHF (bhf2016@163.com). The session report takes priority over other recommended reports.

Nominees will be notified about the Selection Committee's decision immediately after the meeting. The results are published during the BHF in 2016. The nominees are required to participate in all activities of BHF throughout.

The BHF-Award winners become directly "BHF-Scholar" and he or she will be invited to BHF annually. As BHF-Scholar, he or she is supposed to make contribution to the development of the forum.

Members of Selection Committee and relevant staffs should NOT commit the following acts:

- Disclosure of contents of the work for BHF-Award
- Giving of or asking for gifts and money
- If the immediate family committee members participate in BHF-Award competition, the Selection Committee must be informed and the relevant personnel should not affect the results.
- Other acts, which hurt the reputation of the Selection Committee
