Presenters may be kindly asked to discuss another paper. Young researchers are particularly encouraged to submit proposals.

Registration Fee:

The conference fee is \leq 100. For participants who present a paper, the conference fee is reduced to \leq 75. The registration fee covers conference materials, coffee breaks, and the lunch break.
