The Mannheim Centre for Competition and Innovation (MaCCI), a joint initiative of the Centre for European Economic Research (ZEW) and the University of Mannheim, is pleased to announce its 2017 Annual Conference. The aim of the conference is to provide a platform for exchange and discussion on topics in competition- and innovation-related research between academic researchers and practitioners in public authorities, legal counsel, and economic consultancies. Submission of Papers or Abstracts: Full papers as well as extended abstracts (three pages minimum) may be submitted; paper submissions are preferred. All proposals must include the following information: an abstract of up to 200 words, author's full name and affiliation as well as contact details. All papers or abstracts should be submitted to the organising committee via macciannual2017@zew.de as a PDF file no later than December 21, 2016. Proposals must be in English. Authors of accepted papers or abstracts will be notified no later than January 14, 2017. Presenters must register by February 15, 2017, and may be asked to discuss another paper. Young researchers are particularly encouraged to submit proposals.

Registration Fee: The conference fee is EUR 180. It covers conference materials, coffee breaks, and lunch. The conference fee will be waived for presenters.
