Cultural enterprises do not find is quite so easy to attract private equity providers, who are often dubious about the risk profile and return potential of these enterprises simply because they are not familiar enough with them.

CultuurInvest, the investment fund for the Flemish cultural industry wants to bridge the gap between culture and the economy. CultuurInvest wants to give cultural enterprises access to venture capital and thus create space for structural growth and professionalization.

CultuurInvest **does not** offer grants. The fund invests risk capital in enterprises and expects to see a financial return.

# What does CultuurInvest have to offer you?

Depending on the growth stage and the exact needs of your enterprise, CultuurInvest can offer three different types of investments:

- Growth capital
  - Risk capital investments for more mature growth companies through share participation.
- Project financing
  - Short-term financing for specific projects
- Subordinate loans
  - Longer-term limited loans, which may be converted into shares

Moreover, CultuurInvest also wants to offer their partners management advice and guidance

Application	You convince us of you product and market approach

Sectors such as:

- the audiovisual sector and digital design
- the music- and concert industry
- design and designer fashion
- the printed media and graphic design
- publishers and book shops
- musicals and stage art
- distribution within the visual arts.

This list is by no means exhaustive.

Cultuurinvest does <u>not</u> invest in cultural organisations which receive structural funding from the Flemish Government.

CultuurInvest can also make access to **financing easier** by referring you to Vinnof, the Flemish Innovation Fund, or to the Waarborgregeling [Guarantee Arrangement] – two products from the ParticipatieMaatschappij Vlaanderen (PMV)-, or to private investors or the federale Participatiefonds [Federal Participation fund]

To qualify for investment you must submit a convincing **business plan** or we can draw one up together, step-by-step. CultuurInvest will analyse and discuss this plan with you and thus increase the strategic chances of success for your company.
