Authors of accepted proposals will be notified before August 1, 2012. Completed papers will be required before August 31, 2012, and will be posted at <http://www.zew.de/cp2012>. The website will periodically provide updated information regarding the workshop. Presenters may kindly be asked to discuss another paper. Young researchers are particularly encouraged to submit proposals. Travelling and accommodation costs of paper presenters will be covered partly.

The workshop fee for non-presenters is € 120. It covers conference materials, coffee breaks, dinner and lunch on the second day of the workshop. The number of workshop participants is limited to 22. All participants are required to register no later than August 24, 2012.
