1. Executive Summary

This document is the 10th deliverable of Work Package 8 - Dissemination, Exploitation and Communication of the FRAME project, funded by the European Commission through its H2020 programme (Grant Agreement number 727073).

D8.10 - Dissemination, Communication and Exploitation Report - Year 2 sets out the project activities under Work Package 8 against the project objectives for the WP as stated in the previous deliverable 'D8.3 - Dissemination, Exploitation and Communication Report - Year 1'.

This Report provides an overview of the activities that were delivered during the second project year. It summarises the deliverables met as set out in the 'Description of Action' and 'Initial Dissemination, Communication and Exploitation Plan' (D8.2). The Report notes that all deliverables were successfully met, and details the specific stakeholders targeted, the channels used to promote and distribute the project's findings and provides evidence of their impact.





Framework of Communication, Exploitation and Dissemination Activities

2.1 Roadmap of Activities

Over the course of the second year of the project, the research has developed and matured enough to be ready to present preliminary results. This allowed for communication of findings with the project stakeholders and an increase in the dissemination activities by the consortium. The impact and target numbers set in the Description of Action and the Initial Communication, Dissemination and Exploitation Plan were achieved. Moreover, CEPR has launched some additional dissemination activities to maximise the impact of the research. More details are available in the following sections.

2.2. Roles and Responsibilities

CEPR is the work package leader and collaborates with the project partners to ensure they fully engage with the WP objectives. However, the project's coordinating institution, ZEW, leads on decision-making in relation to the communication and dissemination of the project as a whole, including being responsible for hosting and maintaining the project website (http://www.h2020frame.eu/frame/home.html).

The **website** provides links to all project outputs and we have observed an increase of visits over the course of the project. The infographic below summarises the overall impact of the website. More detailed statistics are provided in the Appendix.



CEPR took the leadership on the following dissemination and communication tools: project newsletter, social media, VoxEU activities (columns and podcasts), the organisation of the Final Policy Conference, press releases and the production of some of the videos (specifically the video interviews, conducted at the Research Workshop in Lund).

ZEW managed the video production, produced two policy briefs and distributed press releases.

2.3. Summary of Year 1

During the first year of the project, the partners developed the tools for the visual identity of the FRAME consortium - the project logo, templates, website, hashtag for social media updates. These tools were used in the cycle of the project to increase the visibility of the project and acknowledge the support of the European Commission.

3. Communication, Exploitation and Dissemination Activities

E-Newsletter

The project Newsletter is distributed by CEPR biannually to all project subscribers, to CEPR affiliated researchers (active in the fields of Macroeconomics and Growth and Industrial Organisation) and to a large contact list, provided by ZEW, consisting of representatives of the academia, industry and policy-makers. The total number of FRAME subscribers is currently 3,876.

CEPR committed to sending five newsletters in total, which was successfully delivered.

Two newsletters were distributed during Year 1 and three during Year 2.

The third newsletter was sent in month 16 (July 2018) to 4,096 subscribers and attracted 1,128 opens (25%). This edition focused on the results of the Midterm FRAME Policy Conference and announced further events to be held by the project: the Research Workshop in Lund, the Training School in Mannheim and the Lunchtime Debate in Brussels, all of which took place in month 19.

The fourth FRAME newsletter was sent in month 21 (December 2018) to 3,835 subscribers and received 987 opens (26%). It announced the Final Policy Conference and included an overview of the research highlights and past events.

Although there has been a slight drop in subscribers, the total number of opens of the newsletter has increased on overall.

The final project newsletter provided an overview of the final project results and the events in the final phase of the project. It was sent at the end of month 24 (March 2019) together with this deliverable. The impact statistics are not yet available. Social media

CEPR has posted on Twitter on behalf of the consortium and the partners have re-tweeted these posts. Moreover, ZEW has also tweeted in parallel via their institutional account in German and in English.

It is a responsibility of all project partners to share and post updates on FRAME via their communication channels. In order to keep track of all tweets, the partners have used the hashtag dedicated to FRAME: #FRAMEEU.

The main social media platform CEPR used to promote the project results was Twitter. Additionally, some important updates were also shared on the CEPR Facebook and LinkedIn pages to maximise the impact of the posts. CEPR currently has over 16,200 followers on Twitter, 17,200 on Facebook and over 2000 followers on LinkedIn.





Twitter

The target of posts we had set within the project Dissemination, Communication and Exploitation plan, was 60 tweets in total for the consortium over the lifetime of the project.

<u>To date, CEPR has posted 62 tweets and ZEW 32, exceeding the initial target.</u> The infographic on the following page shows an overview of the impact of the joint activity of CEPR and ZEW.

LinkedIn Blog (additional activity)

In addition to the committed outputs, CEPR has decided to launch an additional activity - a LinkedIn blog, aimed at the general public. We have planned eight posts in total, presenting the main findings of the project in an accessible way, using less technical language in order to reach a broader audience.

The first post is introductory and presents an overview of the project. Posts 2-7 are dedicated to the project outputs and provide the general audience with the opportunity to get familiar with the findings of WP 1 to WP 6. The last post will summarise the project findings and will discuss the broad impact of the research on technological adoption, productivity growth and innovation policy.

VoxEU

VoxEU (https://voxeu.org) is CEPR's Policy Portal. It is an established platform with a very extensive outreach in the academic and policy-making community.

In the second year of the project, one VoxEU column and 2 podcasts (VoxTalks) were created and promoted by CEPR. For the entire project, two VoxEU articles and two podcasts were published by CEPR. ZEW researchers co-authored the VoxEU columns.

The column on *Fiscal austerity and its impact on productivity growth* was published on 26th February 2019 by **Francesco Bianchi (CEPR)**, Diego Comin (CEPR), Howard Kung and Thilo Kind (both LBS). It is available on the following link (https://voxeu.org/article/slow-recoveries-through-fiscal-austerity) and on the project website.

So far, it has attracted 1,671 reads.

The first project **podcast** on the *Impact of Innovation* was uploaded on the 28 September 2018.





It is an interview with the project leader and CEPR team member, Prof Diego Comin by <u>Tim Phillips</u>, a journalist covering business, technology, economics and innovation and who has conducted and produced VoxTalks interviews on CEPR's behalf for the last few years. The talk has received more than 597 hits (205 listens) and is available here: https://voxeu.org/voxtalks/impact-innovation.

The second Vox podcast was produced as a follow-up to the FRAME Final Policy Conference, which took place on the 18-19 February 2019 and was hosted by CEPR. It was published on the VoxEU platform on the 8 March 2019 and has attracted over 240 hits so far (292 listens). The podcast on *Innovation Policy for Europe* was a series of interviews with some of the speakers at the conference as well as some of the project team. Tim Phillips interviewed Roman Arjona (DG Research, European Commission), Diego Comin (CEPR and Dartmouth College), Francesco Bianchi (CEPR and Duke University), Reinhilde Veugelers (KU Leuven), Dietmar Harhoff (Max Planck Institute for Innovation and Competition) and Jonathan Haskel (Imperial College and Bank of England). Furthermore, CEPR has taken advantage of the extensive outreach that the VoxEU platform provides to promote some of the additional project activities. The target set for the duration of the project was three videos and in total, we have produced nine (two in the first year of the project, created by ZEW, and seven in the second year of the project, created by ZEW and CEPR).

Lunchtime Debate video

One video was created by ZEW at the Lunchtime Debate, organised in Brussels, on the 17 October 2018. The video provided a summary of the discussion and short interviews with key attendees - Diego Comin (CEPR and Dartmouth College), Georg Licht (ZEW), Marja Makarow (Biocenter Finland and University of Helsinki), Luc Soete (University of Maastricht and UNU-Merit) and Kurt Vanderberghe (DG Research, European Commission).

Research Workshop, Lund

The second FRAME Research workshop took place in Lund, on **15-16 October 2018** and was hosted by the Centre for Innovation, Research and Competence in the Learning Economy (CIRCLE). The workshop was opened by Sylvia Schwaag Serger (Deputy Vice-Chancellor at Lund University and an Expert at the EC Expert Group on Macro-Economic Modelling, EC)





who highlighting in her welcome speech the ongoing challenges to design research and innovation policies in Europe. In addition to the FRAME project members, Giuseppe Berlingieri (OECD), Guido Cozzi (St.Gallen University, MONROE project), Joseba Martinez (London Business School) presented their recent work on the effect of business cycles and innovation policies on technological adoption, but also productivity growth and labour dynamics. The workshop represented a good opportunity for the project team to discuss the new modelling and methodological approaches by receiving feedback from a wide range of stakeholder groups.

Lunchtime Debate, Brussels

This Lunchtime Debate was held on **17 October 2018** at the Representation of the State of Baden-Württemberg to the European Union in Brussels. The discussion focused on how scientific knowledge can best serve the private sector and be translated into innovative products by companies. The panellists included Georg Licht (ZEW), Diego Comin (Dartmouth College and CEPR), Marja Makarow (Biocenter Finland), Luc Soete (Maastricht University) and Kurt Vandenberghe (European Commission).

Research Training, Mannheim

The Training School took place on **18-19 October 2018** at the Centre for European Economic Research (ZEW) in Mannheim.

The event introduced participants to new methods and tools to assess the impact of public research on innovation, productivity growth, and unemployment. The main focus was the new generation of Dynamic Stochastic General Equilibrium (DSGE) models, developed within the framework of the project.

FRAME Final Policy Conference

The conference took place on 18-19 February 2019 in London and was hosted by CEPR.

The first day of the event focused on the new approaches to macro modelling for policy design and policy-making across countries and sectors to foster adoption of technology and growth in productivity. The second day of the conference was dedicated to research looking at promoting innovation and the diffusion of technology for maximising productivity and greener economies.

The FRAME Scientific Advisory Board together with the Chief Economist of DG Research, Dr Roman Arjona, met and formed a panel discussion on productivity stagnation and polarisation, chaired by Tim Phillips (CEPR). An additional panel convened at the end of the second day involving Jonathan Haskel (Bank of England), Reinhilde Veugelers (KU Leuven, EC Macro Expert Group), Dietmar Harhoff (Max Planck Institute) and Albert Bravo-Biosca (Nesta) looked at innovation policy, R&D funding and maximising productivity in Europe.

5. Synergies with related projects and initiatives

FRAME has developed its synergies with another H2020 project - MONROE. Having ZEW affiliated researches in both project teams has facilitated the interaction between the scientists who are working on complementing models and applying different methods.

During the second year of the project, two joint FRAME-MONROE research workshops took place.

- MONROE-FRAME technical workshop -7 June 2018
- MONROE-FRAME assessment workshop 14 March 2019

Representatives of the partnering project teams attended several project events. One of the MONROE team members presented at the Research Workshop in Lund, while two other MONROE key researchers attended the Final Policy Conference in London. In addition, some of the FRAME teams have also interacted with two other H2020 projects - ISIgrowth and I3U.

Furthermore, at the Final Policy Conference, Ramon Marimon, the Scientific Co-ordinator of another H2020 project - ADEMU, gave a keynote presentation, focused on that project's key findings. Philippe Aghion also presented a paper, which emanates from his ERC Advanced Grant on "Innovation, firm dynamics and growth".


