The Mannheim Centre for Competition and Innovation (MaCCI), a joint initiative of the Centre for European Economic Research (ZEW) and the University of Mannheim, is pleased to announce its 2014 Annual Conference. The objective of the conference is to provide a platform for competition- and innovation-related research and debate between academic researchers and practitioners in public authorities, legal counsel, and economic consultancies. In 2014, the first day of the conference is devoted to the law and economics of horizontal merger control with special sessions on mergers in narrow oligopolies and minority shareholdings. The second day is dedicated to original research papers from all fields of competition law and economics. Theoretical and empirical papers as well as case studies are welcome. We especially invite papers by lawyers focusing on EU competition law and/or comparative competition law.

Authors of accepted papers or abstracts will be notified no later than January 20, 2014. Presenters may kindly be asked to discuss another paper. Young researchers are particularly encouraged to submit proposals.

Registration Fee: Participation on the first day of the conference is free of charge. For the full conference, the conference fee is EUR 110. It covers conference materials, coffee breaks, and lunch. For presenters, the conference fee will be waived.
