Proposals must be in English. Authors of accepted papers or abstracts will be notified no later than January 10, 2015. Presenters may kindly be asked to discuss another paper. Young researchers are particularly encouraged to submit proposals.

**Registration Fee:** The conference fee is EUR 180. It covers conference materials, coffee breaks, and lunch. For presenters, the conference fee will be waived.
