1 MaCCI at a Glance

What is MaCCI?

“MaCCI” stands for “Mannheim Centre for Competition and Innovation”. Its major objective is to stimulate and disseminate research in the area of competition, regulation and innovation policy, broadly defined.

Who are the initiators of MaCCI?

MaCCI is an initiative by the Centre for European Economic Research (ZEW) and the Department of Law and the Department of Economics of the University of Mannheim. Launched as a virtual platform in 2008, MaCCI has become a Leibniz-ScienceCampus as of January 2012.

2 MaCCI Snapshots

In 2016, MaCCI members were active in many areas of both the academic community and practice. On the next few pages, we would like to highlight several key events as well as specific achievements by current or former MaCCI members.

December 2016: MaCCI Senior Member Michelle Sovinsky Receives ERC Grant



The European Research Council (ERC) supports top researchers based in Europe with very generous funding to focus on their research. Receiving an ERC grant therefore is not only a financial achievement but also a great recognition of a researcher's previous work. Michelle Sovinsky, who joined MaCCI in 2015, will use the grant to continue her research on illegal markets. Illegal markets make up a significant part of the world economy, with illicit substances and counterfeit markets reaching an annual value of up to \$300 billion each. This economic activity, however, remains unobserved due to its criminal character, and is therefore not incorporated into the economic models that policy makers rely on to make their decisions. In her ERC grant application, Michelle Sovinsky proposes to develop novel models that would account for unobserved economic behaviour. Her research will focus on three yet under-studied spheres: consumption of illicit drugs, counterfeit production, and illegal counter-competitive actions of legal firms. Prof. Sovinsky will propose and test new estimation methods to better analyse each of these three spheres. The research may provide policy makers with useful tools to understand the illicit markets despite their obscure nature.

November 2016: Lawyers and Economists Exchange Ideas in MaCCI Workshops

One of MaCCI's main ambitions is to promote the exchange between lawyers and economists in the field of competition policy. Therefore, two workshops were organized in the end of November this year: the MaCCI Competition and Regulation Day and the ZEW-MPI Workshop on Private Law and Economics. The MaCCI Competition and Regulation Day is an internal event with presentations from MaCCI members working at ZEW and in both the law and the economics department of the University of Mannheim. For the second workshop, the Max-Planck Institute (MPI) for Comparative and International Private Law in Hamburg is an important partner. MaCCI and the MPI have taken turns in hosting the joint workshop now over the course of four years.

November 2016: MaCCI Law and Economics Conference on Cartel Damages in Europe

On November 10 and 11, 2016 the Centre for European Economic Research (ZEW) and the University of Mannheim jointly organised the Annual MaCCI Law and Economics Conference. More than 50 participants from both academia and practice attended this year's event that focused on the EU Directive on Antitrust Damages Actions in general and the challenges in implementing it into the respective national laws in particular.

Highlights of the conference were the two keynote lectures by Margaret Levenstein (University of Michigan, USA) and Wouter Wils (European Commission and King's College, UK).

November 2016: Thomas Fetzner Heard As Expert on New Telecommunication Regulation Law in German Bundestag

On November, 7, 2016, MaCCI Senior Member Thomas Fetzner provided an expert opinion on proposed changes to German law on the regulation of telecommunication markets for the German parliament, giving important guidance to policymakers. While there were other experts representing for in-

stance companies and consumers, Thomas Fetzer was the only expert from academia who received this honour and opportunity.

November 2016: MaCCI Workshop with German Ministry for Economics on Appropriate Regulation for Telecommunication Industry

In September 2015, a team of 7 MaCCI members and 2 external cooperation partners was selected to provide expert opinions on a regulatory framework for the digital economy for the German Ministry for Economic Affairs and Energy. Multiple policy events taking place at the premises of the ministry in Berlin and Bonn are substantial to the two year project. On November 4, 2016, an important workshop on the regulation of telecommunication markets took place in Bonn. MaCCI Senior Member Thomas Fetzer provided a first evaluation of a suggested regulatory changes and discussed for the ongoing legislative process on EU level.

October 2016: MaCCI Director Thomas Fetzer Joins International Project on Antitrust Law in China, Europe, and the U.S.

International businesses often face a bewildering variety of laws that vary widely from country to country. With fines in the area of antitrust law sometimes approaching or exceeding \$1 billion, global companies are calling for more research into what constitutes good antitrust enforcement practices.

To address these challenges, MaCCI has joined a project led by Penn Law's Center for Technology, Innovation and Competition (CTIC), with Penn Law professors Christopher Yoo and Jonathan Klick, and Wharton professor Joseph Harrington to launch a three-year study comparing antitrust law in China, Europe, and the United States. MaCCI director Professor Thomas Fetzer will examine competition law in the EU. Professor Huang Yong, the Director of the Competition Law Centre of the University of International Business and Economics (UIBE), and Professor Guobin Cui, Director of the Center for Intellectual Property at the Tsinghua University School of Law, will evaluate Chinese anti-monopoly law.

The first year will focus on whether current administrative enforcement practices satisfy the demands of procedural fairness and the rule of law. Financial support for the project is being provided by Google, Microsoft, and Qualcomm.

August 2016: MaCCI Participates with Large Delegation at EARIE

As every year, the European Association for Research in Industrial Economics (EARIE) held its annual conference in the end of August. This year, it took place in Lisbon (Portugal) from 26-28 August with Nova School of Business and Economics being the host. MaCCI members successfully applied for 15 presentation slots at this important conference. Our speakers were Kai Hüschelrath, Martin Peitz, Michelle Sovinsky, Konrad Stahl (all MaCCI Senior Members), Sven Heim, Ulrich Laitenberger, Kathleen Nosal, Bettina Peters, Dominik Schöber, Nicolas Schutz, Chengsi Wang (all MaCCI Junior Members), Johannes Ditttrich, Niklas Dürr, Michael Hellwig and Christoph Wolf (all MaCCI Doctoral Students). MaCCI is looking forward to send many of its researchers to the 2017 edition of EARIE in Maastricht as well. MaCCI Senior Member Volker Nocke was elected to be the scientific chair for that year. He is becoming a successor of fellow MaCCI Senior Member Michelle Sovinsky, who had the honor of being the scientific chair in 2015.

June 2016: MaCCI Summer Institute

In its 2016 edition the MaCCI Summer Institute provided opportunities for MaCCI researchers and international scholars to interact on various competition policy issues. These included business practices such as exclusive dealing, non-linear pricing, and minimum advertised price, competition in two-sided markets, and competition policy regarding patent pools.



June 2016: MaCCI Senior Member Thomas Fetzer Provides Expert Opinion in German Parliament

On June 8, 2016, the transport board of the German Bundestag discussed a proposed new law that intends to facilitate the expansion of digital high-speed networks in Germany. As MaCCI conducted extensive research on the subject, Professor Thomas Fetzer was asked to provide an expert opinion and thus help policymakers to implement effective new provisions. The public hearing took place at the seat of the German parliament in Berlin.

June 2016: 3rd International Conference on the Dynamics of Entrepreneurship

On June 6 and 7, the third International Conference on the Dynamics of Entrepreneurship took place at ZEW. About 90 participants enjoyed 39 paper presentations, one panel discussion and four keynote speeches. The two-day conference was the most important MaCCI event for our researchers in the field of innovation.

June 2016: 14th ICT Conference

On June 3 and 4, 2016, ZEW held its 14th Conference on the Economics of Information and Communication Technologies. As in the previous years, the objective of the conference was to discuss recent scientific contributions to the economics of information and communication technologies (ICT) and the economics of ICT industries. The conference was supported by MaCCI.

The programme featured keynote speeches by Christopher Forman (Georgia Institute of Technology) and Joshua S. Gans (University of Toronto) as well as 37 presentations in parallel sessions.

May 2016: Expert Dialogue on a Regulatory Framework for the Digital Economy Continues

In September 2015, a team of 7 MaCCI members and 2 external cooperation partners was selected to provide expert opinions on a regulatory framework for the digital economy for the German Ministry for Economic Affairs and Energy. Multiple policy events taking place at the premises of the ministry in Berlin are substantial to the two-year-project. After the successful kick-off in February, the second main workshop took place on May 30, 2016. Numerous policymakers, researchers, and representatives of different government bodies as well as involved enterprises were participating. MaCCI senior member Thomas Fetzer chaired the discussions.

During the talk, theses for the green book (a formal summary of the state of the debate) were presented.

May 2016: 10th CLEEN Workshop in Bonn

Since 2007, MaCCI is a member of the Competition Law and Economics European Network (CLEEN), which hosts a yearly workshop for doctoral students who are interested in the field. In 2016, the second German member of the network, Bonn's Max-Planck-Institute for Research on Collective Goods, organized the event in the Gustav-Stresemann-Institute of the former German capital. MaCCI doctoral students Niklas Dürr, Stefan Frübing and Michael Hellwig presented their ongoing research and took the chance to exchange their ideas with other young researchers.

May 2016: Mannheim Energy Conference

On May 19 and 20, 2016, the fifth edition of the Mannheim Energy Conference took place. MaCCI was particularly delighted to host keynote speeches by Christophe Gence-Creux (ACER & EU), Steven Puller (Texas A&M University), Nils-Henrik von der Fehr (University of Oslo) and Mar Reguant (Northwestern University). Moreover, 38 papers were presented in parallel sessions.

April 2016: Achim Wambach joins MaCCI

With his inauguration into the office of ZEW president, Achim Wambach is also joining MaCCI as a Senior Member. Mr Wambach, who is also the chairman of the German monopolies commission, will particularly promote MaCCI's research activities with respect to market design. Having studied mathematics and holding a PhD in physics, he is strongly supporting interdisciplinary research. There is no doubt that MaCCI will hugely benefit from the support of one of Germany's most renowned expert on economic and competition policy.



March 2016: Fifth MaCCI Annual Conference

On March 3 and 4, 2016, the Centre for European Economic Research (ZEW) and the University of Mannheim jointly organised the fifth annual conference of the Mannheim Centre for Competition and Innovation (MaCCI). About 95 participants, including many renowned researchers and practitioners, attended the event to discuss cutting-edge and highly relevant research issues with regard to competition and innovation from an economic and legal perspective. The three keynote speeches by Pierre Larouche (Tilburg University), Christopher Yoo (University of Philadelphia) and William E. Kovacic (King's College London) marked the highlights of the conference.

February 2016: MaCCI Presents Meta-Study at German Ministry for Economic Affairs

In September 2015, a team of 7 MaCCI members and 2 external cooperation partners was selected to provide expert opinions on a regulatory framework for the digital economy for the German Ministry for Economic Affairs and Energy. Multiple policy events taking place at the premises of the ministry in Berlin are substantial to the two-year-project. The first main workshop of the

expert dialogue series took place on February 25, 2016. Numerous policymakers, researchers, and representatives of different government bodies as well as involved enterprises participated. MaCCI senior member Irene Bertschek presented a meta-study in which the project team reviews the state of plenty digital markets in Germany.

4 Research Projects and Research Output

MaCCI members were very active in conducting research in the areas of competition, regulation and innovation law and economics. In the following, we start off by briefly describing three larger MaCCI projects. In addition, we provide a full list of all publications achieved by MaCCI members in 2016.

Research Projects

PROJECT1:

EXPERT DIALOGUE REGULATORY FRAMEWORK FOR THE DIGITAL ECONOMY

Apart from independent research projects, one of MaCCI's tasks and goals is also to provide expert opinions for policymakers. From September 2015 to August 2017, MaCCI is going to show and evaluate policy options for a regulatory framework for the digital economy in a project that was commissioned by Germany's Federal Ministry for Economic Affairs and Energy (BMWi). The project deals with the digital economy in the strict sense, i.e. the provision of digital infrastructure, content and services, and with the digitalization of other sectors of the economy. Based on a meta study that surveys the current state of the digital economy, the project partners look at different aspects more in depth in several studies. These are discussed in workshops with stakeholders from business, science, and politics. The project team consists of seven MaCCI members as well as Prof. Dr. Heike Schweitzer (Free University of Berlin) and Prof. Dr. Jan Krämer (University of Passau).

PROJECT2:

PUBLIC AND PRIVATE ENFORCEMENT OF COMPETITION LAW

In this project, we focus on the question of an optimal design of competition law enforcement. We investigate both public and private enforcement perspectives with a particular focus on the derivation of implementable standards guided by an law and economics approach. By investigating real case exam-

ples, we aim at building bridges between academic research and practical implementation.

PROJECT 3:

EVALUATION OF COMPETITION POLICY RULES AND INSTITUTIONS

In this project, we start with an initial assessment of particular competition policy rules and institutions from a law and economics perspective. From a law perspective, comparative analyses are especially important while an economics approach demands an econometric evaluation of the effects of certain rules or institutions on market competition. Subsequently to an identification of reform potential, we aim at deriving policy conclusions on how the respective rules or institutions can be improved by explicitly taking the perspectives of both law and economics into account.

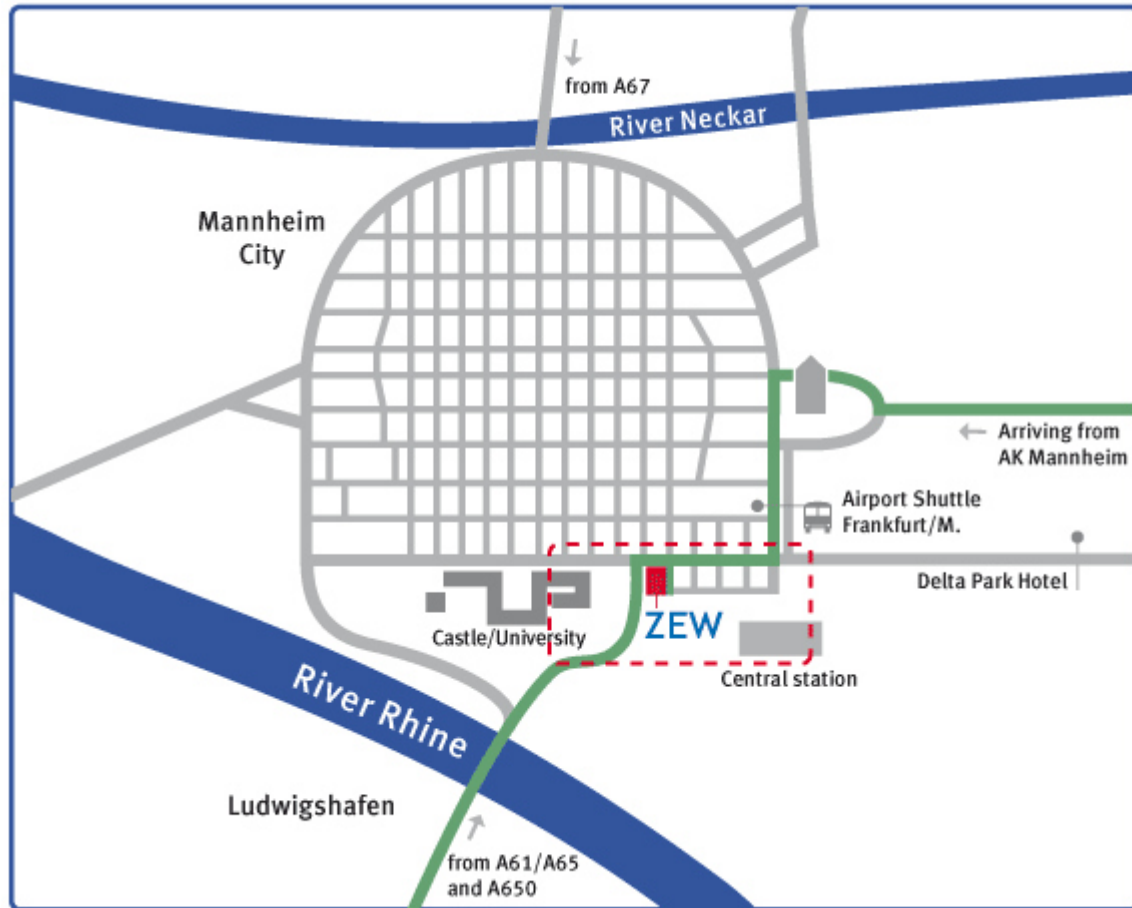
